Dear Friends,

“IT’S TOUGH TO MAKE PREDICTIONS, ESPECIALLY ABOUT THE FUTURE.” YOGI BERRA

This is one of my favorite quotes, and it is so true in this era of healthcare reform. Having served at the helm of The Chester County Hospital for more than 30 years, I usually have hospital and health matters at the forefront of my mind. As the nation’s leaders discuss and debate this big question about creating a health system that works for everyone, I encourage you to consider the particulars of the conversation. The decisions could affect you and your family.

The first question to understand is, “How are healthcare costs measured?”

For employers and individuals with health insurance, the cost is our monthly premiums. To insurance companies, the cost is the negotiated payment to health providers for the services they render. Hospitals calculate cost by how much we spend to provide the care, including supplies and salaries. The Government sees cost as the percentage of the Gross National Product, which is currently more than 17% for healthcare. Finally, people without health insurance know cost as the “charges” they must pay out-of-pocket for healthcare services. So depending on which group you are in there is much room for confusion.

The second question to consider is, “If costs are understood and controlled, does this assure value?”

The biggest driver of value is “quality.” Historically however, quality has never really been clear, measurable, or rewarded in healthcare.

But, the tide is turning as Washington considers the idea of “pay for performance.” Tracking the outcomes of medical procedures and comparing the data against that of competing hospitals is now standard in the industry. Within the past few years, this comparative data has been made available online to the public so that they can be “informed consumers” of their own health needs. This transparency in healthcare is helping to shape the national dialogue about cost, quality and value.

As a resident of Chester County and a friend of the Hospital, another question you might ask yourself is, “So how will The Chester County Hospital fare with healthcare reform?”

Transparency and value have always been a hallmark of The Chester County Hospital because we are governed by the people we serve. It is of primary importance to them that we keep our costs low and our quality high. Nevertheless, since size and negotiating power have determined reimbursement with health insurers rather than value, our reimbursement rates have historically been lower than that of our competition. So, if the reform changes create parity in reimbursement for hospitals based on quality and cost, then The Chester County Hospital will excel. The published data speaks for itself. We are already a high-quality, low-cost provider as compared to our neighboring competitors.

As an independent institution, we are nimble enough to adjust to any situation and are confident that our model of care will guide us through this time of change, as it has done since our founding in 1892.

On behalf on my colleagues, thank you for your continued gracious support and for choosing us to be your hospital of choice. We are thankful for your kindness and generosity.

Thank you for your commitment to The Chester County Hospital Foundation. Despite a troubled economy, you – our generous supporters – have continued to make the Foundation a priority. We attribute our successes to your loyalty to the mission of the Hospital. This Donor Report reflects contributions made during fiscal year 2009, which ran from July 1, 2008 through June 30, 2009. I am pleased with the results of our fundraising efforts, which raised an impressive \$5,724,450 from 2,648 donors.

You have chosen one or more ways to support the initiatives of the Foundation and, thus, have contributed to our overall fundraising efforts. In fiscal year 2009, \$3,866,942 was raised from 489 donors in support of the West Pavilion Expansion. Our Annual Appeal efforts brought in \$386,642 from 2,046 donors. The Special Events that occur throughout the year generated \$476,700 in contributions. For close to two years, Charles Herwegh was diligent about getting to his appointments at The Chester County Hospital's Wound Care and Hyperbaric Medicine Center. Once or twice a week, he arrived for treatment for the ulcer on his leg. The Wound Care employees recall he was always on time, and he always wore his plaid hat. He was occasionally grumpy, but they could usually get him to smile, and he was appreciative of their care and effort.

The last few years of Mr. Herwegh's life were difficult. In his late 80s, his routine became very limited because of his health. He was still mentally sharp, but his body often would not cooperate, making it hard for a man who was so independent. Simple things that once filled his day, such as tending to his garden, became difficult, if not impossible. Visits to his doctors, to The Chester County Hospital, and to Wound Care became more frequent. And, with these frequent visits came the bills.

Mr. Herwegh received caring support from The Wound Care and business office staff.

Late Charles Herwegh's Story

Having spent his teenage years living through the Great Depression, Mr. Herwegh learned lessons about the importance of frugality and saving that lasted a lifetime. Living in the same house in West Chester most of his life, he eschewed many modern household items; few upgrades had been made to his house since 1930. However, he was diligent about paying his bills. When he was unable to pay the entire balance of his bill for Hospital services after insurance payments, he contacted the Hospital's Patient Billing Office. They qualified Mr. Herwegh for the Hospital's charity care program and enrolled him in a manageable monthly payment plan.

Mr. Herwegh made his payments on a regular basis until his passing in January 2008, after which Mr. Herwegh's friend and estate executor, Paul Stevens, fulfilled the balance of the bill. Six months later, an unexpected letter arrived at the Hospital's Foundation Office. Mr. Herwegh

had left nearly his entire estate, consisting mainly of his house and antique clock collection, to The Chester County Hospital Foundation. Mr. Stevens recalls that when Mr. Herwegh was getting ready to write his will, he included the Hospital "because they treated me decent."

We never had the chance to thank Mr. Herwegh for his gift while he was alive, and perhaps that is how he intended it to be. A man who grew up in the Depression may have been uncomfortable with the attention his gift would surely bring. But, the impact of his generosity and the message it sends about Mr. Herwegh and what was important to him, will be remembered for many years to come.

The Gretchen

Gretchen Bowker's story is one of passion inspired by a loving husband, a Hospital that cares, and doctors who treat the patient, not just the disease.

Her late husband, Gordon "Gordy" Bowker, was the life of the party. Clients of Gretchen's company, The Chester County Travel Agency, loved traveling with Gordy and Gretchen as much as they loved visiting exotic locations. Together, they took more than 100 cruises and, sadly, it was on a European cruise in 2006 that Gordy became ill. He had been under the expert care of David Grossman, MD, since his cancer diagnosis in 2000. Gordy's treatment at The Cancer Center of The Chester County Hospital extended his life, but was not able to prevent the cancer from spreading. Gretchen lost Gordy a little more than a week after returning home from that European cruise.

The following year, Gretchen celebrated Gordy's life with friends and family on a memorial cruise. Not one to sit back and relax even on a cruise, Gretchen wanted to do more. She was determined to help others in their battle

with cancer and give back to the caring staff and doctors who "were wonderful, especially Dr. Grossman. He treated my family, my husband and me with care and compassion."

Gretchen decided a golf tournament would be a natural fit, since Gordy was an avid golfer since age 18. Friends and family worked together and the Gordon 'Gordy' Bowker Memorial Golf Tournament was started. In the three years since its inception, the June tournament has raised more than \$58,000. Gretchen specifies the money be used to enhance patient care. Today, there are new ergonomic recliners for chemotherapy treatments and a big screen television that acts as a welcome distraction. Outside The Cancer Center, there is a tranquil garden.

Care for cancer patients is also supported by the long-running fundraising event, SHINE. Even though she may be exhausted after months of planning Gordy's golf outing, Gretchen actively participates on the SHINE committee. In support of her fellow committee members, she helps organize an amazing November evening of dinner and
