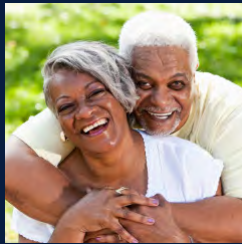

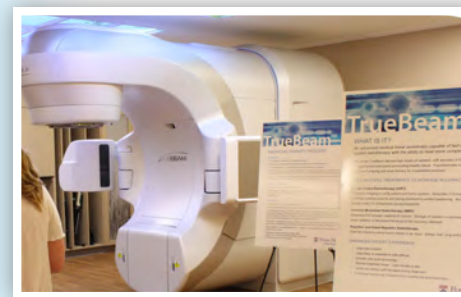

Chester County Hospital enjoyed an exciting and monumental year. Because of your ongoing commitment, our philanthropic efforts were outstanding and the strides we made both clinically and operationally were equally impressive.

Some highlights include our quality and patient satisfaction measures. They continue to be among the highest in the region. We opened our new patient Tower, the Lasko Tower, named in honor of the Lasko Family for their years of generosity toward our organization. Our new TrueBeam™ linear accelerator was installed and we implemented a new model of care in the Emergency Department that has dramatically improved customer service and has reduced treatment times. Fiscal year 2013 was an exciting year for The Chester County Hospital Foundation and Chester County Hospital. I am happy to say that it was one of our best fundraising years to date. We could not achieve this success without the tremendous support of you, our donors.

With your help, the Foundation secured \$11,574,162 in outright gifts and pledges to support initiatives, such as the Lasko Tower and the Emergency Department reconfiguration, as well as unrestricted funds to be used for the Hospital's greatest needs.

The actual cash the Foundation received was \$7,235,424 from 2,536 donors, which includes Annual Giving gifts, Campaign gifts, Memorial gifts, Planned Giving gifts and donations from Special Events.

Pledges and donations from the Capital Campaign helped make possible the construction of the Lasko Tower. The Grand Opening of the Lasko Tower was celebrated at the end of June 2013, with patients utilizing the fourth floor on July 1, 2013. We were delighted to celebrate this momentous occasion, with many of you in attendance.

With the number of non-profit organizations and causes that need support, I am pleased to see that 2,069 Annual Giving donors have chosen Chester County Hospital as a philanthropic priority. Your donations will continue to be essential in helping Chester County Hospital fulfill its mission to be the leading provider of care in the region.

The Women's Auxiliary is unwavering in its support of the Hospital. Each year, we receive a generous donation from the Auxiliary, resulting from Special Events it holds throughout the year, as well as from sales at the Gift Shop and the Encore consignment shop. 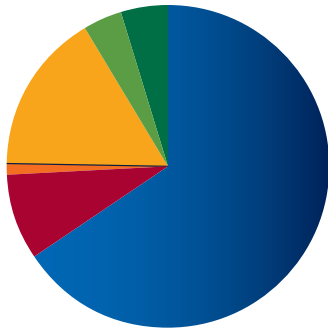

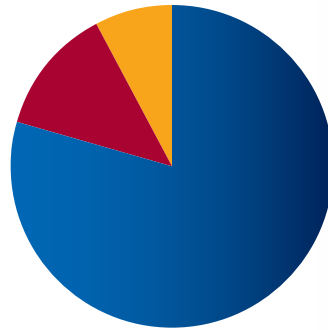

A LOOK INSIDE CHESTER COUNTY  
HOSPITAL'S EMERGENCY DEPARTMENT  
RECONFIGURATION

The Emergency Department (ED) is a place we all hope we never have to go, but occasionally we find ourselves in a situation that places us in the ED, either for ourselves, a family member or a friend. With donations of more than \$5 million from some of our generous donors, we've been able to implement enhancements to our ED that in the end help make what is often a stressful experience a little less stressful for our patients and their families.



The process to enhance the ED began with the engagement of a consulting team that included an Emergency Medicine Physician from Penn State Hershey Medical Center and industrial engineers from Penn State. The team examined all aspects of the ED. They identified changes that have enabled us to implement an innovative model of care that combines the highest level of emergency treatment with unmatched efficiencies and customer service.

One of the primary recommendations was to implement a process known as Physician Directed Queuing (PDQ). In this process, walk-in patients will see an ED physician or physician assistant for initial assessment in a Rapid Treatment Area upon their arrival in the Emergency Department.

Betty Brennan, RN, EdD, CNML, Director of Emergency Department says, "The consultants predicted PDQ will reduce the total wait times by 77% and the average patient stay in the ED by 53%. This would allow us to treat roughly 9,000 more patients each year. We currently see more than 40,000 people every year."

The PDQ process was implemented in May 2013, and at the end of August 2013,

the wait times for walk-in arrivals were reduced by 80% and the length of stay reduced by 50%. In addition, the median time to be seen by a provider for the four months after implementation, averaged less than 10 minutes.

Another element to improve patient flow in PDQ is diagnostic testing and results process. One of our local family foundations donated more than \$500,000 to purchase technology that speeds specimen collection, expedites lab results and enhances safety and quality.

In addition to the PDQ process and the technology, the ED will be renovated as a result of an extraordinarily generous donation of \$2.5 million from a private foundation. The renovation will enhance the patient experience from the front door to an ED patient bed, and then onto admission or discharge. This transformation will occur over the next year.

Another supporter of the ED project is our dedicated Women's Auxiliary. The Women's Auxiliary pledged \$500,000 toward the ED project, to be paid through their numerous annual fundraising efforts. *(Continued on the next page)*

## NEW PATIENT TOWER: THE LASKO TOWER

**A**t the end of June, we were delighted to celebrate the Tower Grand Opening! The construction of the Tower would not have been possible without the generous support of our donors. Over \$35 million has been raised from more than 700 donors in our campaign efforts.

Our first patients and families were welcomed on July 1, 2013 to the Telemetry Unit on the fourth floor. The radiation therapy suite on the ground floor has been in use since August 2013. The second floor, which will house private rooms for Maternity, and the third floor, which will be the orthopedic surgical unit are under construction with opening dates set for 2014.

The new patient Tower was designed to offer the very best in patient-centered design with spaces configured to promote comfort and healing. This is visible throughout the completed fourth floor and the radiation therapy suite on the ground floor.

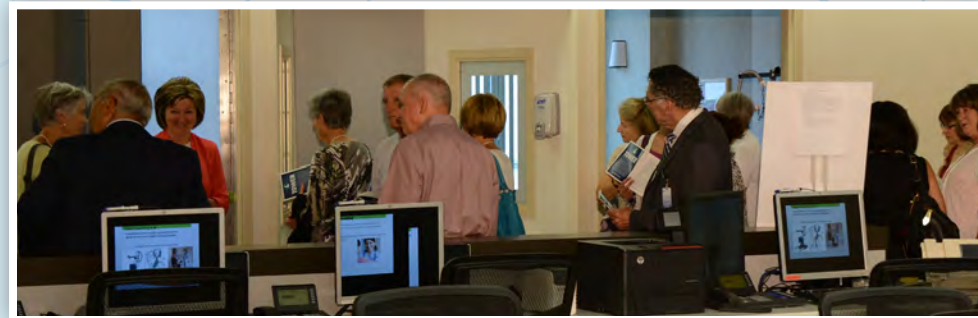
The fourth floor Telemetry Unit offers features such as private rooms filled with natural light, more space for visitors, and spacious bathrooms. These features will be present in the patient rooms on the second and third floors as well.

Each patient room is arranged to best serve the needs of the patients and families. Each room has three zones. Zone 1, just as you enter the room, is for the nurses or other caregivers, with a sink and ample countertop workspace, medical supply cabinets and a computer within easy reach. Zone 2 is designated for the patient, with the bed facing a footwall that is clean and uncluttered. The patient has full control of the TV and window shade system. In addition, the patient has easy access to the bathroom. Zone 3 is for family members and friends, featuring a convertible seating system that can function as a couch, a recliner, and even a bed when it is closed and flipped over.

Another patient-centered feature that enables the nurses to spend more time at the bedside is the configuration of the two nurse stations rather than one central station. This allows each station to serve 12 rooms rather than one station serving 24 rooms.

The stations are positioned so that nurses have a line of site to each room. The unit also is equipped with small workstations with a computer between each pair of rooms to allow nurses and doctors to update and retrieve information on a medical record without disturbing the patient.

The ground floor contains the Varian TrueBeam™ Linear Accelerator. This device offers speed, accuracy and safety in radiation therapy. The TrueBeam™ system makes it possible to aggressively track tumors with greater precision and far less time than earlier generations of radiation delivery systems.

To ease the anxiety of patients entering this space, three beautiful backlit nature scenes were placed on the walls in the corridor and can be seen as the patient enters the suite. In addition, two backlit scenes featuring a blue sky, clouds and trees were placed on the ceiling above the linear accelerator. These features give patients a peaceful view to focus on while they are receiving their treatment.

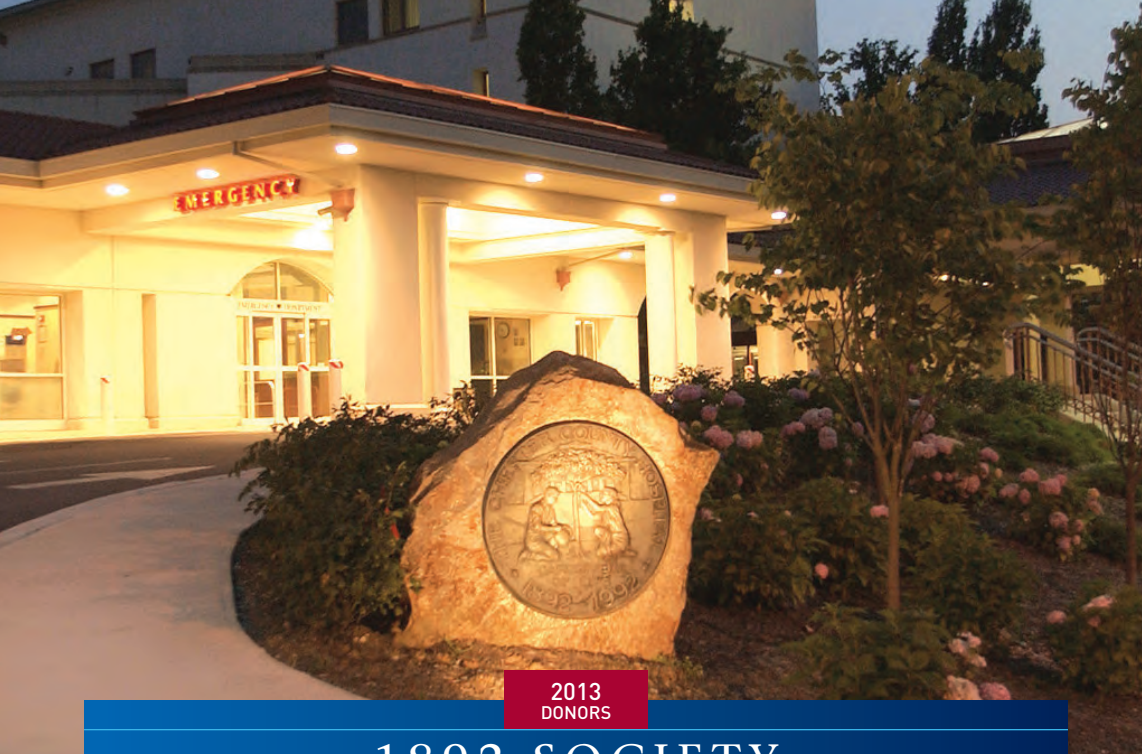

## FUTURE PLANS FOR THE LASKO TOWER

**A**s we celebrated the grand opening of the Lasko Tower and the use of the fourth floor for our Telemetry patients, construction continued on the remaining two floors.

The third floor of the Tower will house the orthopedic surgical unit, and the second floor of the Tower will house our Mother and Baby Pavilion.

Like the Telemetry Unit on the fourth floor, both units will contain 24 private rooms with the rooms designed with three distinct zones for Family, Patient and Clinician. Each room is designed with the comfort and safety of the patient in mind.

The orthopedic surgical unit will be dedicated to the post-operative care of patients who have undergone orthopedic surgeries. It will offer the latest in specialized inpatient services, including the most current technologies and patient amenities. The new unit will include a modern rehabilitation gym that will feature additional tools to help patients return to their full function faster.

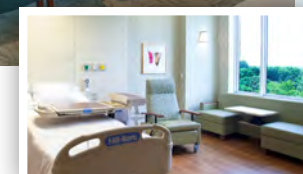

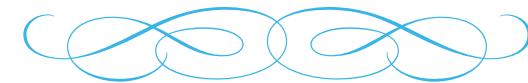
