# Detter from the PRESIDENT AND CEO

Dear Friends,

ince integrating with Penn Medicine two years ago, the momentum of growth at Chester County Hospital continues at an exhilarating rate. This year was one of the most successful in our history. From inpatient admissions and emergency department visits to newborn deliveries and clinical recognition, we outpaced every other hospital in our service area.

Last November our nursing department achieved Magnet<sup>®</sup> recognition as a reflection of its professionalism, teamwork, and superiority in patient care. This accomplishment is determined by the American Nurses Credentialing Center's (ANCC) Magnet Recognition Program<sup>®</sup>, which ensures that rigorous standards for nursing excellence are met.

We received the 2014 Achieving Patient Care Excellence (APEX) Platinum Award in April for our clinical team's progress in preventing surgical site infections and pressure ulcers, patient falls and deep vein thrombosis.

Our community is benefiting from expedited Emergency Department care as part of our patient flow redesign. With little to no crowding in our waiting room, we are

converting much of this space into triage bays in order to create more capacity in our acute care



completed, we will have expanded the number of patient rooms in our Emergency Department by twenty percent.

Emergency Department

Residents of southern Chester County now have access to our brand new medical complex, Penn Medicine Southern Chester



County, located in Penn Township. More than 300 area residents joined us for the opening of the building in June. Located off of Route 1, this health care destination offers many medical services and primary care in one convenient location.

As part of Penn Medicine, Chester County Hospital's already exceptional medical staff continues to add clinical talent. This has resulted in many key subspecialties being made available locally. Patients who require specialized treatment in areas such as neuroscience and cardiovascular disease have more options for care close to home. With our expansion into complex cancer modalities, we are now part of the Abramson Cancer Center, a world leader in cancer treatment and research, and can offer even more advanced therapies and expertise.

Expectant mothers throughout Chester County are enjoying the spaciousness of our new private maternity rooms. Our Lasko Tower echoed cries of joy as we welcomed 2,600 babies this yeara ten percent jump over last year's births! Approximately one out of ten infants born here will require care in our Neonatal Intensive Care Unit. So to meet this demand, we are currently expanding our existing NICU space.

Underpinning our success has been the steadfast support of our donors. Every area that I have mentioned served as a growth point for us this year and all of these points have directly benefited from philanthropy. The strength of your generosity is reflected in the face of every patient we treat and every newborn we greet. We are grateful for your support as we seek more opportunities to serve our great community.

ince 1999, when Pat and John Celii established The Patricia C. and John Celii, Jr. Foundation, a strong bond has formed with Chester County Community Foundation (CCCF), where Beth Harper Briglia, CPA, CAP, Vice President, Donor Services & Grantmaking, has become a trusted advisor. Chester County Hospital would ultimately benefit from this partnership.

Several years ago, the Hospital saw the need for a Women's Specialty Center where women with cancer diagnoses and related health concerns could find compassionate care in a restorative atmosphere. Specialty services would include breast care, gynecologic/ oncology, urogynecology, and genetic counseling, all conveniently located near the Women's Imaging Center and Pathology. However, \$500,000 was needed to fund the project.

John recalls, "Knowing that we love living in Chester County and that we have an interest in healthcare programs and medical research to benefit the area, CCCF presented the opportunity." Pat and John responded with a generous \$250,000 challenge grant. Their challenge was met with an equal gift by an anonymous benefactor of Chester

County Hospital, providing the critical funding to launch the Women's Specialty Center at Chester County Hospital's Fern Hill Campus.

This project was appealing to the Celii family, particularly to Pat and their two daughters, Jacqui and Stephanie. They had personally struggled with coordination of care between multiple specialists, complicated appointment scheduling, and frequent trips throughout

> the suburbs and downtown Philadelphia to see various doctors. The Celii women envisioned a comprehensive center that would alleviate those frustrations and improve care outcomes for other women. Pat said, "We are very excited that Chester County Hospital has placed a priority on providing an innovative approach to women's health issues. We are

pleased that so many women will benefit from this initiative."

Chester County Hospital Foundation is thankful for other generous grants the Celii family has made in collaboration with Chester County Community Foundation over the years, including funding for DaVinci Robotic Surgery technology, Emergency Room renovations, and a major commitment to the new Lasko Tower. # HEALTHY MOMS, HEALTHY BABIES


hester County Hospital's Prenatal Ob/Gyn Clinic is removing barriers to convenient, quality care for all women and expectant mothers in our community. Healthy pregnancies lead to healthier mothers and babies. Receiving appropriate medical care is essential throughout pregnancy, from the earliest weeks of pregnancy through delivery and following the baby's birth. Unfortunately, for some expectant mothers, acquiring appropriate, comprehensive prenatal care can seem beyond their reach.

Many of the women who come to Chester County Hospital's Prenatal Ob/ Gyn Clinic are facing challenges like language barriers, financial struggles, or a lack of awareness about the need for prenatal care. Many are overwhelmed, discouraged or even afraid. They need help understanding pregnancy and childbirth, and how to navigate through the health care system.

Chester County Hospital

has been serving the health care needs of underinsured and uninsured women for more than 50 years, providing gynecology care, prenatal care and childbirth deliveries, regardless of the woman's insurance status.





early all of our Prenatal Clinic patients struggle in poverty. Low economic status means a higher-than-average number of medically diagnosed high risk pregnancies. The national high risk pregnancy average is between 6-8% compared to 20% of our Clinic patients. Yet, our birth outcomes remain outstanding compared to national averages. Nationally, some 12% of all babies are born at less than 2,500 grams (5.5 pounds), while at the Prenatal Clinic less than 5% of these fragile babies are born at such a weight.

The Clinic team includes physicians on staff at Chester County Hospital, nurse practitioners, registered nurses, and a bilingual (Spanish) staff of medical assistance representatives and financial counselors, ensuring accessible care for the entire community. Patients can visit Clinic locations in either West Chester or Kennett Square.

The Prenatal Ob/Gyn Clinic also relies on

volunteers, grant funding, and community support as they diligently serve the community year after year. In 2015, the Women's Auxiliary to Chester County Hospital made this initiative one of

their fundraising priorities, directing proceeds from the Polo Cup and The Encore Shop to help underwrite Clinic expenses. Chester County Hospital's Ob/Gyn Clinic strives to provide inclusive community health. By helping to ensure that all women have access to gynecology, maternity, and prenatal care close to home, the Clinic continues to significantly impact the lives of countless mothers, babies, and families in Chester County and surrounding communities, such as Delaware and Montgomery Counties.





Chester County Hospital recently renovated two catheterization (cath) labs and is in the process of upgrading a third. When patients experience heart problems, they are often taken to a cardiac cath lab. This specialized laboratory allows for closer evaluation and treatment of the

heart through a catheter or thin flexible tube. The latest renovations are enhancing the labs with advanced X-ray equipment for superb imaging clarity. Updated digital viewing technology allows the clinical team to view multiple images of the heart from a number of sources, at the same time. Design of the layout and space utilization allows the flexibility needed to perform multiple types of electrophysiology and cardiovascular procedures, allowing for optimum patient scheduling.

# INNOVATION

#### **TECHNOLOGY MOVES** CARE rtvara

As part of Penn Medicine, our patients have access to the most advanced treatment options and radiotherapy technologies. Adding to these resources, with support from the Women's Auxiliary, Chester County Hospital purchased 3-D breast imaging technology, also termed 3-D digital tomosynthesis. The three-dimensional imaging allows for a higher degree of accuracy in detection of suspect tumors and masses. Patients find the experience less invasive and more comfortable than traditional mammograms.

The newly-purchased CT Simulator generates a computerized tomography (CT) scan to precisely design treatment plans

for patients with cancer, sparing the surrounding healthy tissue. The CT Simulator includes a movable laser feature for exact tumor marking and consistency throughout the treatment process. Another addition for patients needing specialized therapy, High-Dose Rate (HDR) Brachytherapy, uses a miniscule



radioactive source positioned near the cancer site for a brief period of time. This approach delivers high doses of radiation to a defined target without impacting nearby tissue.

Because radiation oncology is a science of exactness, the latest technologies accommodate for natural patient movements-breathing, sneezing, yawning-and the radiation beam is




# CONTINUING CHERISHED

At the young age of 67, Bunny also returned to school to earn her credentials in Expressive Art Therapy to continue improving outcomes for her patients.

Bunny says, "When it was time to plan for our senior years, we didn't fully realize how

brilliant it was to choose continuing care at Whitehorse Village in Newtown Square. Joe has been in their specialized memory unit for the past three years and is receiving excellent care. He still recognizes me and smiles, we are able to spend time together, but he has trouble forming words." Even though conversation isn't possible, Dr. Joe's love of music is still as sharp as ever. The staff at Whitehorse Village are fond of bringing him into the kitchen early in the morning. They select one of his favorite CDs-maybe Frank Sinatra or the sound track from Finian's Rainbow (1968). While they make breakfast, Joe serenades with perfect timing of each note and lyric.
